2. Share Purchase Rationale

Ichigo Office has been notified by Ichigo that Ichigo is purchasing additional Ichigo Office shares to further strengthen its commitment to Ichigo Office as its sponsor and drive growth and shareholder value for Ichigo Office shareholders. To provide immediacy and certainty in the execution of today's share purchase, Ichigo is purchasing the shares from Ichigo Trust Pte. Ltd., a major Ichigo Office shareholder.

Ichigo Office and Ichigo Hotel (3463) are the only J-REITs implementing a no fixed fee, performance-fee only structure that fully aligns with value creation for Ichigo Office and Ichigo Hotel shareholders. Ichigo Office believes that Ichigo's share purchase will support its growth and drive long-term shareholder value.
