### Proposed Amendments to Articles of Incorporation

Ichigo Real Estate Investment Advisors Co., Ltd. (IRE), the asset management company of Ichigo Office REIT Investment Corporation (“Ichigo Office REIT”), has decided to submit the following amendments to the Articles of Incorporation for resolution at its annual shareholder meeting on May 29, 2016.

1. Purpose of the Proposed Amendments

- 1) To simplify its corporate name to “Ichigo Investment Advisors Co., Ltd.,” reflecting the expansion of its asset management business into the expanding green infrastructure asset class, as announced in today’s release “Corporate Name Change of the Asset Management Company.”
- 2) To set our corporate mission, which is rooted in the *Ichigo Ichie* philosophy of sincerity and service.
- 3) To allow for potential future business developments by broadening our business purpose.
