

#### Corporate Reorganization


IIA is eliminating what had been a separate Finance Division to integrate its functions into the divisions responsible for managing Ichigo Office, Ichigo Hotel, Ichigo Green, and Private Funds, respectively, to increase the autonomy and capabilities of these divisions. IIA is also establishing a new AM Execution Division to handle contract documentation, regulatory disclosures, and investor relations.
