## 3. Organization


To manage the Ichigo Hotel REIT Investment Corporation ("Ichigo Hotel REIT"), IRE has established a new Hotel REIT Division, comprised of the Hotel REIT Asset Management Group and Hotel REIT Portfolio Management Group. The Hotel REIT Asset Management Group will be dedicated to asset acquisitions and sales and hands-on management of the REIT's assets, while the Hotel REIT Portfolio Management Group will be in charge of portfolio management and monitoring. IRE will also establish a new Investment Management Committee, the REIT's top decisionmaking body, for Ichigo Hotel REIT, and eliminate the Special Projects Division which was in charge of planning Ichigo Hotel REIT.

In addition, what was previously the REIT Division has become the Office REIT Division, comprised of the Office REIT Asset Management Group and Office REIT Portfolio Management Group. Ichigo REIT's Investment Management Committee (J-REIT) has been renamed the Investment Management Committee (Office REIT). No other changes in the personnel structure of the Office REIT Division have been made besides the aforementioned in sections 1 and 2.


